

## **EUMCCI INDUSTRY SECTOR COMMITTEES**

Advocacy is an important aspect of EUMCCI's service. We forward issues, and dialogue with the relevant Malaysian agencies, matters of concern faced by member companies regarding implementation of local trade and investment regulations. The Industry Committees are composed of senior management of member companies in relevant sectors. They are:

- **Logistics** - Logistics Committee has individuated three areas of priority: develop a code of practice for logistics sectors, the integration of inter modal transport and tackle hijacking. Visits to operators of the sector and surveys in the region are also part of the Committee's agenda.
- **Construction & Building Materials** - The aim of the Committee is to enable key issues impacting the industry to be identified and prioritised. The Committee interfaces with various industry bodies and develops a regular dialogue with relevant government departments.
- **Intellectual Property Rights (IPR)** - The IPR Committee monitors and engages in investigation and enforcement. It offers a platform for companies to voice out their problems and issues and organises trainings with the Customs in order to prevent imports of counterfeit goods into Malaysia
- **Corporate Social Responsibility (CSR)** - The Committee will address issues pertaining to how companies can adapt their global CSR policy/strategy in the Malaysian environment.
- **Education** - The Committee will move forward "The Bridging the Gap" initiative involving academia and industry with three key initiatives i.e. the internship program, placement of academia in industry and placement of captains of industry in curriculum review boards of universities.
- **Editorial Committee** - The Editorial Committee is in charge of all in-house publications.
- **Air Transport Committee** - Leveraging with the strengths of 27 countries, the new Air Transport Committee is the ideal platform to voice key issues related to the air transport industry. Air Transport Committee provides members the space to exchange, brainstorm and develop new ideas as well as draft relevant guidelines and most of all enhance our cooperation with Malaysian and European authorities and/or representatives. Among the committee's stated objectives are:
  - Promote enhanced aviation safety and European safety standards
  - Raise awareness of European aviation practices
  - Development of routes between EU-Malaysia

  - Promote Malaysia as an Asia Aerospace Hub
- **Oil and Gas Committee** - The Oil and Gas Committee looks at issues related to upstream i.e. deep water and marginal fields, manpower i.e. sourcing and training, cooperation with EU on renewable energy initiatives as well as promote Malaysia as an Oil and Gas Deep Water Hub
- **Information, Communication and Technology Committee** - Information, Communications and Technology is a highly dynamic and innovative industry that drives economic and social progress in all the economies around the world. It is estimated by year 2015, over 5 billion people will be connected and much of that is because of what the ICT industry delivers to all the people in most of the countries.  
ICT Committee provides members the space to exchange, brainstorm and develop new ideas as well as draft relevant guidelines and most of all enhance our cooperation with Malaysian and European authorities and/or representatives.
- **Defense and Security** - The Defence and Security Committee provides members the space to exchange, brainstorm and develop new ideas as well as draft relevant guidelines and most of all enhance our cooperation with Malaysian and European authorities and/or representatives. Among our stated objectives are:

  - Development of Transfer of Technology Policies
  - Cooperation: EU-technology initiatives
  - Education & technical training
  - Promote Malaysia as an Asian Defence and Security Hub
- **Environment, Energy and Green Technology Committee (EEGT)**  
Objectives of the Committee are:
- Provide its members with information concerning environmental matters and green/clean energy issues
  - Function as a forum where members can exchange experiences, information and share concerns
  - Have regular meetings with opinion leaders or highly ranked government officials involved in environmental and energy policy making processes and address our members about the structure, the regulations and the prospects of the sector
  - Address issues of concern with the relevant government authorities for further action through our position paper, lobbying and face to face interaction with government officials
  - Facilitate the bilateral cooperation and business between EU and Malaysia

Objectives of the Committee are:

- To lobby on issues related to the above with the relevant government authorities
- To assist member companies on labour issues e.g. work permit, levy
- To engage the government specifically Ministry of Human Resources on how to improve labour conditions and labour laws
